- Nuclear enterprise will become more focused and centralized, demanding more resources from other areas









# **AF State of Logistics**




- Resource constraints will continue to mount – it's getting worse, <u>Not better</u>
- Manpower costs rising approximately 6% annually
- Cost per flying hour increasing
- Equipment continues to age
  - Average aircraft age now 23+ years
- PBD 720 manpower reductions implemented across Total Force
- Nuclear enterprise becoming more focused and centralized, demanding more resources from other areas


